1. The use of above mentioned vehicle shall be used for Election Work only. The Model Code of Conduct for Elections must be followed in letter and spirit. Any violation will be viewed seriously.
2. A public address system or loudspeaker or any sound amplifier, whether fitted on vehicles of any kind whatsoever, or in static position, used for public meetings for electioneering purposes, shall not be used at night between 10:00 p.m. to 06:00 a.m.
3. The Loudspeaker / PA system shall not exceed the permitted decibel limits as per the Hon'ble Supreme Court directions and shall not cause any inconvenience to the nearby residents and general public.
4. No voters are allowed to be transported in the above mentioned vehicle.
5. The organizer should not conduct Public Meeting, Dharna, Rally, use of loudspeaker slogan shouting etc. within the area of 100 Mtrs. of Collectorate as it covers under Section 144 of Code of Criminal Procedure, 1973.
6. The organizer should not play loudspeaker near Temples, Mosques, Church and Hospitals etc.
7. The organizer should maintain law & order during the campaign.
8. The organizer should obey orders of Sector Officer / Police Officers / Traffic Police.
9. The vehicles shall not be carrying any arms, firearms, or ammunition and other deadly weapons like stick or lathy, cudgel, swords, spears, bludgeons, knives or any other article which is capable of being used for causing physical violence.

10. The vehicle will follow the provisions of Motor Vehicles Act & Rules and Representation of People Act.
11. The Permit signed by the District Election Officer / Returning Officer (in original) (enclosed herewith) shall be affixed prominently on the windscreen of the above mentioned vehicle.
12. The details of the Expenditure incurred shall be submitted to the Nodal Officer (Election Expenditure Monitoring) in Annexure – D1 (Copy enclosed) within 24 Hours.
13. The permission may be cancelled or revoked at any time, if, deemed fit by the undersigned.
